Amendment to by-laws in regard to nominations for Life Membership of the Ormond Angling Club - Bylaw clause Amendment:

In 2014 Prior to the AGM the Club financial members (bar one) were advised of a Motion to amend clause (c) of the Club's By-Laws.

Clause (c) currently reads:

## "Not more than two such honours shall be conferred in any five year period."

Therefore under (c) we would be unable to confer another Life Membership until 2015.

## Amended Clause (c) Not more than three such honours shall be conferred in any five year period.

#### The criteria to be:

- 1. Attend as many as possible Club meetings, Social events and Working Bees, etc
- 2. Work in other areas e.g. open and set up the hall ready for meetings and/or close the hall after the meetings
- 3. Organise and carry out maintenance and other work for the Club
- 4. Organise guest speakers, etc
- 5. This award is to be open to all Club members and fishing of any sort will not be attached to this award except for a social day
- 6. The members must sign all attendance books in order to be recorded as attending the event
- 7. The Executive only to decide the winner of this award who name shall be recorded on the shield
- 8. Suggested trophy money \$70.00

### Points to be awarded for attending the various events:

General Meetings	5 points
Members Nights	5 points
Social Events	5 points
Sinker making days	5 points
Open and/or close the Hall	5 points
Carry out maintenance or other work for the club	10 points
Junior angling and similar events	10 points
Club working bees	10 points
Introduce a new paid-up members	10 points
Organise guest speakers, etc	10 points

Recording for some events may not be practical (e.g. opening or closing the hall); ultimately, the Executive Committee will decide the winner of the award, using as many of the inputs as are available.

During season 2014/15 a number of events occurred that had an influence on the club's activities:

#### **Administration**

- Continuing improvement in the club's financial situation
- The induction of a number of new members
- The notification by the hall lessee of intention to vacate the premises at the end of December 2015

#### ATTACHMENT B FROM ANGLING SECRETARY

First of all, I will summarise our four categories:

- 1. On the bay, we had 101 fish weighed in overall with a total bag weight of 26.510 kg, slightly down on last season
- 2. On the Estuary, we had 133 fish weighed in for a total bag weight of 66.560 kg
- 3. On the Freshwater, we had 45 fish weighed in for a total bag weight of 17.080 kg
- 4. On the surf, we had a total of just 9 fish weighed in for a total bag weight of 7.545 kg. This was a very poor result for this season. Hopefully next season will be better.

Overall this season the fishing has been down on previous seasons. So that's the fishing summary for 2014-15

I would like to thank all Angling Committee members for all of their help especially Peter Manning for organising our inter-club barbeques.

Also, I am pleased to see that we are getting a few new members into the club and I hope this continues
