VR Fish/MAA Delegate Report

Victoria's recreational fishers helping protect and improve our valuable fisheries

Recreational fishing licence fees are spent on improving fishing access in the form of new fishing infrastructure along our Victorian waterways. Apart from providing additional fishing platforms, the structures also provide for general public access and activities, such as bird watching. More than \$2 million of our licence fees are spent on education and enforcement by Fisheries Officers every year. Between 2010-2013 more than \$1.8 million of our licence fees was spent on research into Mako sharks, snapper, King George whiting, calamari, black bream.

VRFish 2014 State Election Wish List -

The VRFish Election Wish List 'Growing Recreational Fishing in Victoria' has now

been circulated to the major political parties for consideration. The Wish List has been developed over a 2 year period through consultation with our members and under the auspices of the VRFish State Council and Board. The Wish List covers a range of issues that, if addressed, will help position Victoria as the premier fishing destination in the State. VRFish believe these issues warrant targeted Government investment over the next 4 years. It covers issues such as governance, comanagement, fishing access and infrastructure, fish habitat and environmental management, fisheries research, education, fish stocking and new science to better understand threats to fish stocks in bays and inlets. The document will be available on our website once the various political parties have had time to digest our requests and respond with their policy positions.

Southern Bluefin tuna stocks on the rise

VRFish attended the Australian Fisheries Management Authority recreational fishing forum in Canberra on 17 June. The meeting was attended by leaders of the various recreational fishing bodies from around Australia and is a new initiative to improve consideration of recreational fishing interests in the management of Commonwealth fisheries.

We were presented the latest CSIRO aerial survey results for juvenile southern Bluefin tuna from the Great Australian Bight. The relative abundance of 2-4 year old fish this year is the highest on record and 2 times the long term average. This is great news and a clear sign of further steps towards stock rebuilding.

Greater Alpine National Parks - Draft Management Plan

Parks Victoria has released the Greater Alpine National Parks Draft Management Plan for public comment. The Draft Plan is an important guide to the management of Alpine, Baw Baw, Errinundra, Mount Buffalo and Snowy River National Parks, Avon Wilderness Park, Tara Range Park, and Walhalla, Howqua Hills, Grant, Mount Wills and Mount Murphy Historic Areas.

The draft plan gives recreational fishers an opportunity to contribute to the area's management. VRFish is constructing a submission based on feedback from our members. Comments to Parks Victoria are required by 25 August 2014 and we welcome your comments being sent to info@vrfish.com.au by 1 August.

Parks Victoria and VRFish working together to improve public awareness

VRFish is working closely with Parks Victoria to help improve communication with all users of our valuable natural assets. VRFish is proud of the work that goes back into protecting and improving our fisheries.

Our licence fees are disbursed annually by the Minister for Agriculture and Food Security on a range of vital projects and services that help ensure high quality fishing experiences now and into the future. For example, recreational fishing licence fees are spent on improving fishing access in the form of new fishing infrastructure along our Victorian waterways. Apart from providing additional fishing platforms, the structures also provide for general public access and activities, such as bird watching.

Victorian trout stocks and management under the microscope

VRFish has been working with DEPI and other stakeholders to develop a Draft Trout Response Plan. The draft plan is a direct and collaborative action aimed addressing the current problems facing the trout fishery in Victoria. The draft plan has many components, including research, stock assessment, angler engagement and communication.

On 20 June DEPI held a Trout Reference Group meeting and is developing a plan that will address the following questions:

- Are summer water temperatures adversely impacting river trout fisheries?
- Is there a decline in wild trout breeding?
- Is fishing pressure adversely impacting trout populations?
- Has a reduction in Lake Eildon trout stocking impacted adjacent river trout fisheries?
- Have changes in riparian habitat affected water temperature or the trout fishery?
- Will trout stocking help the wild brown trout river fisheries recover?
- Are current Fisheries regulations adequate to protect or sustain river trout fisheries?
- Is carp or cormorant competition / predator pressure impacting trout fishery?
- How can we reliably measure changes in the performance of the recreational fishery?
- How do we ensure research results are well understood by fishers? A common view among the group is the need to understand, preserve and where possible, invest in measures to recover of the <u>wild</u> brown trout fishery, rather than seeking to change the nature of the wild trout fishery (e.g. by creating a put and take fishery based on stocking).

The preliminary cost of the response plan is approximately \$500,000 over 3 years, plus other co-investment. A commissioning bid will be presented to the RFL Grants Working Group on 15 July 2014. VRFish will be exploring opportunities for further co-investment. Keep in mind the immense social and economic value of the trout fishery to Victoria, especially in regional townships and there is no doubt we need to act.

2014/15 VRFish Business Plan

We have submitted our 2014/15 Draft Business Plan to DEPI. The Plan outlines VRFish actions for the next financial year. There is much to be done over the next 12 months and a clear and concise business plan is vital for the organisation. The 2014/15 plan differs from the previous one. The new plan highlights that VRFish is more than just a body that consults and represents the views of recreational fishers. We are a crucial part of the fisheries co-management framework that is capable of establishing policy with other users on complex and sensitive issues such as resource sharing. Given our extensive networks throughout the recreational fishing community, we are also an important vehicle to achieve the adoption of responsible recreational fishing practices and behaviors.

New fisheries patrol vessel launched at Portland

Fisheries Victoria has welcomed a new patrol boat to its Portland fleet.

Named 'Doris' after the Greek goddess of the sea's bounty, the vessel will undertake inspections of recreational and commercial fishers from Yambuk to the South Australian border. The powerful 8m rigid inflatable vessel is fitted with a hauler for inspections of commercial lobster pots and is powered by twin 200 horsepower engines. It joins two similar vessels already in operation at Mornington and Altona.

The new vessel will provide a boost to fisheries compliance in South West Victoria

BIA Melbourne Boat Show

Finally, the Melbourne Boat Show was a great success again this year. The VRFish stand was a busy place, with lots of fishers asking questions about issues that are important to them – these included boating infrastructure and access, fisheries research, fish stocking and the status of trout stocks in Victoria.

A major VRFish theme was promotion of the 5 simple actions fishers can take to help improve the survival of released snapper. These are fish shallow to avoid barotrauma, leave snapper in the water for release, minimise handling and netting, use circle hooks or lures and release snapper quickly.
